As you know, the Secretary of State will mail directly to voters registered up to E-60; however, the Secretary of State does not mail to overseas, out-of-state, or confidential voters. Counties are responsible for mailing state ballot pamphlets to all of their overseas, out-of-state, and confidential voters, as well as all voters registered between April 9, 2016 (E-59) and May 9, 2016 (E-29).

Once the information has been compiled, we will send you a copy of your completed order and shipping instructions and you will have an opportunity to make any changes at that time.
