A PROCLAMATION
BY THE GOVERNOR OF THE STATE OF CALIFORNIA

I, **ARNOLD SCHWARZENEGGER**, Governor of the State of California, pursuant to section 12000 of the Elections Code, hereby proclaim that a Statewide Direct Primary Election will be held throughout this State on Tuesday, the 8th day of June 2010, at which the following offices are to be filled:

GOVERNOR;

LIEUTENANT GOVERNOR;

SECRETARY OF STATE;

CONTROLLER;

TREASURER;

ATTORNEY GENERAL;

INSURANCE COMMISSIONER;

MEMBER OF THE STATE BOARD OF EQUALIZATION from each of the four equalization districts of the State;

ONE UNITED STATES SENATOR;

REPRESENTATIVES TO THE CONGRESS OF THE UNITED STATES from each of the fifty-three congressional districts of the State;

STATE SENATORS from the even-numbered districts of the forty senatorial districts of the State;

MEMBERS OF THE ASSEMBLY from each of the eighty assembly districts of the State;

SUPERINTENDENT OF PUBLIC INSTRUCTION;

Also, such other state, county, judicial or other officers as are provided by law to be filled at such election.

I further proclaim that at such election there will also be submitted to the vote of the electors such proposed constitutional amendments, questions, propositions and initiative measures as are required to be so submitted by the Constitution and laws of this State.


