

SUBJECT: November General: Updated Certified List of Write-In Candidates

The last day for a candidate to file candidate documents was October 19, 2010. Per Elections Code section 8082, all nomination documents that are required to be filed in the office shall be forwarded to the Secretary of State's office within five days after being left with the county elections official.

However, it has just come to our attention that we were provided with incomplete or incorrect information by county elections officials. Therefore, we are updating the Certified List of Write-In Candidates that was issued Friday, October 22, 2010. The changes to the Certified List of Write-In Candidates are as follows:

- Marcus Jay Shapiro (CD 51) – An updated report was received today showing that the candidate obtained the requisite number of signatures within the write-in period and is now qualified as a write-in candidate.
- Jerry Leon Carroll (US Senate) – Alternate variations of his name are now reflected on the Certified List of Write-In Candidates.
- Rowan Millar (Governor) – Alternate variations of his name are now reflected on the Certified List of Write-In Candidates.
- Long Pham (AD 68) – Alternate variations of his name are now reflected on the Certified List of Write-In Candidates.
