This memo is to request that you please submit your **January 2013** non-DMV monthly voter registration information by February 22, 2013.

SB 35 (Padilla), Chapter 505, Statutes of 2012, effective January 1, 2013, requires county elections officials to begin reporting the number of voter registrations generated by each NVRA agency office or site in the county. SB 35 also requires counties to report to the Secretary of State within 10 days of the beginning of each calendar month.

Therefore, monthly NVRA reports now have two components:

- 1) A one-page report of NVRA category totals; and
- 2) A spreadsheet containing a list of the NVRA agency offices and sites in the county with voter registration totals for each office or site.

Please use the attached forms to complete your monthly NVRA report. County elections officials should maintain an up-to-date list of the NVRA agency offices and sites in the county and add new offices and sites to the list as appropriate. For more information, please refer to CC/ROV #13018.
