May 30, 2006	(E-7)	<b>13. LOGIC AND ACCURACY</b> The last day to send Logic and Accuracy Test certifications to the Secretary of State.	
May 30, 2006	(E-7)	<b>14. ABSENT VOTERS</b> The last day to file applications for absent voter's ballot.	§ 3001
Jun. 6, 2006	(E)	<b>15. SPECIAL GENERAL ELECTION</b> Polls open at 7 a.m. and close at 8 p.m. All absentee ballots must be received by the county elections official by 8 p.m.	§§ 14212, 3020

CERTIFICATION OF ELECTION (CANDIDATES)</b> The last day for the Secretary of State to determine votes cast for Senate and to certify the person having the highest number of votes for that office as duly elected.
