## Deaf & Hard of Hearing Workgroup Recommendation Send a letter to each political party requesting they produce an ASL video with captioning of their Statement of Purpose

## <u>DRAFT LETTER - Secretary of State to finalize</u>

The California Secretary of State's Voter Accessibility Advisory Council (VAAC) Workgroup focused on the Deaf & Hard of Hearing community has recommended a special project to improve this community's voting accessibility in California elections.

The Center for Disease Control (CDC) estimates California has 6,734,666 disabled individuals, 5% of which are deaf or have serious difficulty hearing or 336,733 individuals statewide (Source:

https://www.cdc.gov/ncbddd/disabilityandhealth/impacts/pdfs/California Disability.pdf)

When the VAAC investigated the Deaf & Hard of Hearing community's voting experience, they discovered that most members of this community do not vote. Their first barrier to voting was confusion over how to register to vote. The SOS addressed this issue in 2020 with a video with captioning, using an American Sign Language (ASL) interpreter, which explains how to fill out the California registration form. Their second barrier to voting was their lack of understanding regarding the difference between political parties and therefore they didn't know how to respond to the registration form's section regarding political preference.

To assist the deaf community's voting access, we are reaching out to the Chairs of all six California political parties asking them to create an ASL video with captioning of their Party's Statement of Purpose (currently posted in English on the Secretary of State's website at <a href="https://www.sos.ca.gov/elections/political-parties/party-statements">https://www.sos.ca.gov/elections/political-parties/party-statements</a>). While the texts of these Statements of Purpose are posted online, many Deaf citizens rely on American Sign Language as their language and are not proficient in English.

Our request is that your organization produce a video with captioning of your Statement of Purpose with an ASL interpreter, like the California SOS video on How to Register to Vote, in time for the 2024 Primary Election. If you plan to update your Statement of Purpose prior to the 2024 election, we recommend you record the most current version of your Statement of Purpose for this ASL video.
