RE: VoteCal: Modification of Voting Rights - Mental Incompetency or Specific

Criminal Findings

Pursuant to Elections Code sections 2208 through 2211, county elections officials should be receiving and processing notifications or court orders from their respective county court. When a county court disqualifies an individual's right to vote or restores an individual's right to register to vote related to a determination of mental incompetency or specific criminal findings, the court is required to notify and/or forward the court order to the respective county elections official.

In 2016, Elections Code sections 2208 through 2211 were amended to require the county courts to also notify the Secretary of State with respect to these matters. Once the Secretary of State's office began to receive the court data, our office identified that one of the challenges of using this data to update voter records was a lack of sufficient identifying information in order to make a positive match to a county record. Accordingly, in an effort to obtain specific points of identifying information from the courts, the Secretary of State's office collaborated with Judicial Council to create a standard court form entitled, *Confidential Notification of Court Order Modifying Voting Rights* ("Notification Form"). The Notification Form includes data points the county elections officials can use to make a successful match, including: SSN4, date of birth, home address, and driver license number. (See attached Notification Form.) County courts may use the Notification Form when sending this information to the Secretary of State's office and county elections officials.

When a county elections official receives a notification or a court order (which one they receive will depend on the applicable Elections Code section) from their county court, they should search for the voter within their county Election Management System (EMS) using all data points – SSN4, date of birth, home address, and driver license number – that were provided by the court to find potential matches.

- If the county elections official finds a definite match (as determined by the county reviewing the records), they must take the following action:
 - If the notification or court order indicates that the individual has been disqualified from voting, the individual's voter registration must be cancelled pursuant to Elections Code section 2201(a)(2). It is recommended that the county elections official upload an image of the disqualifying notification or court order.
 - If the notification indicates that the individual's right to register to vote has been restored, it is recommended that the county upload an image of the notification to the voter record. It is important to note that the individual's voter status does not change until the individual submits a new voter registration application. Subsequently, if the individual submits a voter registration application and a match is found, this uploaded image may assist in the determination of voter eligibility.
- If the county elections official does not find a definite match (as determined by the county reviewing the records), they do not need to take any action with respect to the county court's notification or order.
