California Student Mock Election: Register Your School Today!

The 2018 General Election is quickly approaching, and it is once again time to get your students involved and excited about civic engagement. The California Secretary of State and the State Superintendent of Public Instruction are partnering to host another California Student Mock Election on **Tuesday, October 9, 2018**.

Working with the California Campaign for the Civic Mission of Schools and in coordination with the National Student Mock Election, the California Student Mock Election helps young people discover the importance of elections and the power their vote has in our democracy. This year it builds on the excitement of a Statewide Election by giving California's high school and middle school students a chance to cast their mock vote for who they want to be our next Governor, United States Senator, and more. Once their votes are counted, students can compare their votes to those of their peers at schools from across the state.

We encourage you to incorporate this great program into your classroom schedule. Registration for the California Student Mock Election is on the Secretary of State's website at <http://www.sos.ca.gov/elections/student-mock-election/>. Here you will be able to register your school and obtain resources for holding a successful mock election on your campus.

All schools that register by September 18, 2018, will receive printed ballots, posters, "I Voted" stickers, and other materials by mail. Ballots and posters will be available to print on the Student Mock Election website for schools that register after September 18, 2018.

In addition to the materials above, you will find a collection of standards-based lesson plans designed to engage your students as well as ideas that other schools have used to incorporate the Mock Election in their schools.

Another way you can get your students excited about civic engagement is by helping students host a voter registration/pre-registration drive at your school. In California, students can pre-register to vote starting at age 16 on paper or online at <https://registertovote.ca.gov/>. Once pre-registered, they will be automatically registered to vote on their eighteenth birthday.
