## 2. Co-chair Nominations and Appointment

- Reina Miller read the role of the co-chair(s) to the committee and opened the floor for chair nominations.
  - Natalie Adona volunteered as co-chair.
- Maria Valdez nominated Joanna Francescut as co-chair.
  - Joanna accepted the nomination
- The committee unanimously voted to appoint Natalie and Joanna as co-chairs of the committee.

## 3. California Elections Code Division 13

Reina Miller led the discussion by reviewing a [suggested step-by-step approach for the committee](#).

- Whitney Quesenberry asked if there is a possibility to change wording in certain code sections and if so, is there a process where suggested revisions can be reviewed.
- Natalie Adona asked whether the committee can determine practical barriers that are encountered when building ballots or looking at elements of the ballot.
- Raj Bathla stated that because the committee falls under the Bagley-Keene Act, the committee has limitations. The committee must meet in public. Workgroups are allowed to focus on specific items.
- Natalie Adona suggested tackling code sections that the committee deems most critical first since it would be challenging to discuss sections that the committee does not have a clear grasp on.
- Joanna Francescut suggested doing a survey to prioritize sections.

  - Karen Rhea suggested watermarks be done prior to random alpha to allow more time for ballot programming.
  - Liz Oviedo second Karen's suggested that the watermarks should be done prior.
  - Joanna Francescut suggested E-88 as a good time frame.
  - Natalie Adona stated that the watermark causes timing and designation issues, reasonable that counties would want them done sooner since more time can be spent proofing and eliminating the lag.

  - Maria Valdez agrees with Joanna.
  - Jennifer Tagg commented that somewhere in paragraph b or c it should be made clear that the crossover is only for the presidential contest. Also, Article B is not clear what should or should not be included whether it includes central committees or not.
