RE: Redistricting Maps: Corrected Assembly District Maps

On December 28, 2021, the California Citizens Redistricting Commission (CRC) notified the Secretary of State that the Assembly District maps sent on December 27, 2021 (see CCROV # 21215), were not the Commission-approved version. The CRC confirmed and provided the Commission-approved version of the Assembly District maps in the evening on December 29, 2021. Please see the attached email from the CRC detailing the Assembly Districts affected. Per the CRC email, the impacted counties are:

- Alameda
- Napa
- Placer
- Riverside
- Sacramento
- San Diego
- San Joaquin
- San Mateo
- Santa Clara
- Solano
- Sonoma
- Stanislaus

We have removed the previously delivered certified statewide Assembly District maps and have placed the **corrected** certified statewide Assembly District maps as received from the CRC. Corrected files were received in equivalency and shape file formats (CSV and SHP) and have been uploaded into the 2021_Redistricting folder on the

Secretary of State's secure FTP service, Axway. We have also provided **corrected** county specific Assembly District equivalency files on the Axway site.

To ensure your county is using the corrected certified redistricting maps, all counties must:

- **Delete the statewide Assembly District map files from December 27, 2021**

Your county will be able to access these files from Axway and download the files using your county's Axway user account.

Subject: Technological Error Notification

Good evening Steve,

Late last evening, the California Citizens Redistricting Commission's line-drawers informed me they discovered that the shapefile and equivalency files for the final, Commission-approved version of the Assembly District maps were not the files actually sent to the Secretary of State as part of the transmittal of final maps on Monday, December 27, 2021.

The following are a list of errors with the final Assembly District map files provided to your office on December 27, 2021:

- The error in the Assembly District shapefile occurred between Assembly Districts 78 and 79 within the City of San Diego. There are no other issues with Assembly District shapefiles in any other counties or for any other level of districts. Except for San Diego County, all counties working off the shapefile have been working off the correct files.
- The error in the Assembly District equivalency file also did not reflect the Commission's final approved map. These include small adjustments needed to be made to the block equivalency file to conform to the shapefiles. These reflect areas with zero or low population. The following areas are impacted by the corrections we have made to the block equivalency files.
 - Alameda County – unpopulated unincorporated area between districts 15 and 16
 - Napa County – unpopulated unincorporated area between districts 11 and 4
 - Placer County - in Roseville between districts 7 and 5
 - Riverside County- in Murrieta between districts 36 and 71
 - Sacramento County - unpopulated unincorporated area north of Folsom between districts 7 and 5 and unpopulated area in the City of Sacramento between districts 6 and 7
 - San Joaquin County – unpopulated area in Stockton between districts 9 and 22 and unpopulated unincorporated area between districts 11 and 13
 - San Mateo County - unpopulated area in South San Francisco between districts 21 and 19, unpopulated area in San Bruno between districts 23 and 21, and Redwood City between districts 23 and 21
 - Santa Clara County - unpopulated area in Los Gatos between districts 28 and 23 and in Monte Sereno between districts 28 and 23
 - Solano County – unpopulated unincorporated area between districts 4 and 11
 - Sonoma County – unpopulated area in Sebastopol between district 12 and 2
 - Stanislaus County - in Modesto between districts 9 and 22

I wish to emphasize that these minor errors occurred in the course of incorporating the Commission's approved and certified final maps into the appropriate shapefile and block equivalency files. In light of these issues, we have verified the accuracy of all the other files transmitted to the Secretary of State on December 27, 2021. Accordingly, there is no need for any further action on the part of the Commission itself to correct these technical errors.

Per your request, the updated shapefile and equivalency files will be uploaded to Axway. The transmitted zip file is named CRC_2021_Assembly_Final_corrected.zip. All the files and folder names within the corrected Assembly District zip file are appended with "corrected".

Additionally, the new SHA hash for the CRC_2021_Assembly_Final_corrected.zip file is documented and provided in an updated Appendix 6 of the "Final Maps Report with Appendices (12.26.21 230 PM)" Adobe Acrobat PDF document.
