Pursuant to Elections Code section 11104, each county elections official must report to the Secretary of State 30 days after a recall has been initiated and every 30 days thereafter.

The ninth reporting date is March 18, 2021. The ninth report should include signatures turned in by the proponent between February 6, 2021, and March 11, 2021, as well as the cumulative number of signatures submitted since June 10, 2020.

In addition, please report the number of verified and valid signatures received between June 10, 2020, and February 5, 2021. Please also report the number of verified and valid signatures received between February 6, 2021, and March 11, 2021, as well as the cumulative number of signatures verified since June 10, 2020.

As outlined in CCROV #21002, if the 30-business day signature verification period has not yet expired, please report any signatures validated thus far and any remaining valid signatures in your next monthly report.
