(If the Secretary of State notifies the county to determine the number of qualified voters who have signed the petition on a date other than 07/28/22, the last day is no later than the thirtieth working day after the county's receipt of notification.) (Elections Code § 9031(b), (d).)

h. Secretary of State certifies whether the petition has been signed by the number of qualified voters required to declare the petition sufficient. (Elections Code §§ 9031(e), 9033(a))..........Friday, 09/16/22**

IMPORTANT POINTS

- **Top Funders Disclosure Requirement:** Please see Elections Code sections 101, 104, 107, and 18600 for Official Top Funders disclosure requirements effective January 1, 2020.
- California law prohibits the use of signatures, names, and addresses gathered on initiative petitions for any purpose other than to qualify the initiative measure for the ballot. This means that the petitions cannot be used to create or add to mailing lists or similar lists for any purpose, including fundraising or requests for support. Any such misuses constitutes a crime under California law. (Elections Code § 18650; Bilofsky v. Deukmejian (1981) 124 Cal.App.3d 825, 177 Cal.Rptr. 621; 63 Ops.Cal.Atty.Gen. 37 (1980).)
- Please refer to Elections Code sections 100, 101, 104, 107, 108, 9008, 9009, 9012, 9013, 9020, 9021, 9022, and 9203 for appropriate format and type consideration in printing, typing, and otherwise preparing your initiative or referendum petition for circulation and signatures.
