Circulating and Filing Schedule continued:

(If the Secretary of State notifies the county to determine the number of qualified voters who signed the petition on a date other than 04/27/22, the last day is no later than the thirtieth working day after the county's receipt of notification.) (Elections Code § 9030(d), (e).)

- f. If the signature count is more than 1,096,853 or less than 947,283 then the Secretary of State certifies the petition as qualified or failed and notifies the counties. If the signature count is between 947,283 and 1,096,853 inclusive, then the Secretary of State notifies the counties using the random sampling technique to determine the validity of **all** signatures. (Elections Code §§ 9030(f), (g), 9031(a))..................Wednesday, 06/15/22**

(If the Secretary of State notifies the county to determine the number of qualified voters who have signed the petition on a date other than 06/15/22, the last day is no later than the thirtieth working day after the county's receipt of notification.) (Elections Code § 9031(b), (d).)

IMPORTANT POINTS

- Top Funders Disclosure Requirement: Please see Elections Code sections 101, 104, 107, and 18600 for Official Top Funders disclosure requirements effective January 1, 2020.
- California law prohibits the use of signatures, names, and addresses gathered on initiative petitions for any purpose other than to qualify the initiative measure for the ballot. This means that the petitions cannot be used to create or add to mailing lists or similar lists for any purpose, including fundraising or requests for support. Any such misuses constitutes a crime under California law. (Elections Code § 18650; Bilofsky v. Deukmejian (1981) 124 Cal.App.3d 825, 177 Cal.Rptr. 621; 63 Ops.Cal.Atty.Gen. 37 (1980).)
- Please refer to Elections Code sections 100, 101, 104, 107, 108, 9008, 9009, 9012, 9013, 9020, 9021, 9022, and 9203 for appropriate format and type consideration in printing, typing, and otherwise preparing your initiative or referendum petition for circulation and signatures.  Attorney General. Use of this title will assist elections officials in
 referencing the proper file.
- When a petition is presented to the county elections official for filing by someone other than the proponent(s), the required authorization shall include the name or names of the persons filing the petition. (Elections Code § 9032.)
