Eligibility for Ballot

Max Henderson and Anna Maybach, the proponents of PROVIDES FUNDING FOR PANDEMIC DETECTION AND PREVENTION BY INCREASING TAX ON PERSONAL INCOME OVER \$5 MILLION. INITIATIVE CONSTITUTIONAL AMENDMENT AND STATUTE. (#1916), have filed more than 1,096,853 valid signatures with the counties.

Therefore, pursuant to Elections Code section 9033, the initiative measure is eligible for the November 5, 2024, General Election ballot and all further signature verification can be terminated.

On June 27, 2024, the Secretary of State will certify the initiative as qualified for the November 5, 2024, General Election ballot, unless withdrawn by the proponents prior to certification pursuant to Elections Code section 9604(b).
