RE: Voter Registration: Deadline to Order Voter Registration and Voter

**Notification Cards** 

This memo is sent as a reminder to county elections offices needing to order county-specific voter registration cards (OCR VRC) and voter notification cards (VNC; postcard or 15-day notices) with a **delivery date by June 30, 2022**. To meet this deadline, all completed printing order forms for the fourth quarter of the 2021-22 fiscal year must be received by <u>March 15, 2022</u>.

**Please note:** The fourth quarter order of VNCs will continue implementation of the statewide Universal Voter Notification Card (UVNC) and will include changes to the paper color and overall design and content. Both the postcard and the 15-day notice (previous fold-over) VNC will be an 8"x5" flat postcard that is not folded before mailing. The SOS will be reaching out to county VRC-VNC contacts to provide additional information and printed samples for testing.

Please use the attached electronic, fillable order forms. The VRC printing order form should include any National Voter Registration Act (NVRA) agency orders for your county. Please complete a separate printing order form for each of the OCR VRC or VNC (postcard or 15-day notice) language(s). Please check your records to verify the alphabet series and starting six-digit number sequence for the OCR VRC orders. If applicable, please include with your order a sample of your current OCR VRC to be printed, and mark any changes in red ink, e.g., address and phone number.

You may email your order to <u>VRC-VNC@sos.ca.gov</u> OR fax your order to (916) 653-3214. If requesting changes, please include a sample of your current OCR VRC, so we may confirm any changes being requested by your county.
