RE: Presidential Primary: Voter Information Guide (VIG) Mailing

The Secretary of State (SOS) will be processing Voter Information Guide (VIG) mailing labels of registered voters with a valid California mailing address as of E-60 (January 5, 2024) as well as for voters registered between E-59 and E-29 (January 6 – February 5, 2024). The procedure for processing these mailing labels is as follows:

60-Day Mailing

- ❑ **Election Setup:** Verify the March 5, 2024, Presidential Primary Election is set up locally in the Election Management System (EMS) so that VoteCal will have access to the associated precinct/district mapping.
- ❑ **Precinct Setup:** Verify that all active precincts are assigned to the March 5, 2024, Presidential Primary Election.
- ❑ **Synchronization Check:** Complete a synchronization (sync) check and resolve any differences between December 15, 2023, and the time readiness is indicated. ***A successful sync check completed for the 60-day Report of Registration will satisfy this requirement.***
- ❑ **Enter Registrations:** Enter all online and paper registrations into the county EMS with a registration date up to and including the 60-Day Close (January 5, 2024) by January 15, 2024 (E-50).

- ❑ **Complete Readiness Form:** Complete the attached “60-Day Close Voter Information Guide (VIG) Readiness Form” and **e-mail it to votecalhelp@sos.ca.gov no later than January 15, 2024 (E-50).**

29-Day Mailing

- ❑ **Enter Registrations:** Enter all online and paper registrations with a registration date of January 6, 2024 (E-59) to February 5, 2024 (E-29) into the county EMS.
- ❑ **PLEASE NOTE:** The Secretary of State (SOS) will mail state VIGs directly to all non-military voters with domestic mailing addresses (including U.S. territories).

Each county will be responsible for mailing VIGs to:

- ❑ All military and overseas voters
- ❑ Qualified confidential voters.
- ❑ Registrants with registrations that did not get uploaded to VoteCal at the time the SOS extracted the mailing file.
- ❑ Registrants with registrations that did not pass the mailing standardization process.
- ❑ Registrants with a registration date after February 5, 2024 (E-29) by request only.

During the VIG mailing process, some addresses are not deliverable. Records with an out-of-country mailing address will be excluded from the mailing by the State. However, records that are out-of-state and within the United States will be included in the mailing. After the 60-Day Close VIG mailing has been completed, an email will be sent out with specific instructions on how counties are to handle the mailings of VIGs to these addresses.
