RE: Presidential Primary: Delegate Count

The Secretary of State shall certify to the county elections officials the number of delegates to be elected by the following parties: American Independent, Libertarian, Peace and Freedom, and Republican. (Elec. Code, §§ 6320, 6323, 6540, 6543, 6740, 6743.) Attached is a copy of the certificate.

The Chairperson of the Democratic State Central Committee shall notify the Secretary of State as to the number of delegates and alternates to represent the state in the next national convention of the Democratic Party. (Elec. Code, § 6020.) Attached is a copy of the notification from the Democratic Party.

Following the presidential primary election, the number of Green Party delegates will be selected by the national political party with which the Green Party is affiliated. (Elec. Code, § 6863.)
