(If the Secretary of State notifies the county to determine the number of qualified voters who signed the petition on a date other than 04/04/24, the last day is no later than the thirtieth working day after the county's receipt of notification.) (Elections Code § 9030(d), (e).)

- f. If the signature count is more than 601,317 or less than 519,319, then the Secretary of State certifies the petition as qualified or failed and notifies the counties. If the signature count is between 519,319 and 601,317 inclusive, then the Secretary of State notifies the counties using the random sampling technique to determine the validity of **all** signatures. This means that the petitions cannot be used to create or add to mailing lists or similar lists for any purpose, including fundraising or requests for support. Any such misuses constitutes a crime under California law. (Elections Code § 18650; Bilofsky v. Deukmejian (1981) 124 Cal.App.3d 825, 177 Cal.Rptr. 621; 63 Ops.Cal.Atty.Gen. 37 (1980).)
