RE: Presidential Primary: Updated Calculations – Green Party County Council Members

On September 12, 2023, the Secretary of State timely issued a CC/ROV that provided the computations for the number of county council members to be elected in each county at the March 5, 2024, Presidential Primary Election for the Green Party of California pursuant to Elections Code section 7912.

Following the issuance of that CC/ROV and after the statutory deadline to notify our office (set forth in Elections Code section 7903), the Secretary of State's office was notified by the Green Party of California that there are 21 county-specific bylaws that govern the number of county council members to be elected.

The review of those bylaws, in addition to direction from the party, has resulted in changes to the number of county council members in a few counties. The changes for those counties are identified in the attached chart.

Officials from each county will find the appropriate allocation of seats in the attached documents. Any differences from the prior CC/ROV have been highlighted.
