RE: Voting Systems: Logic and Accuracy Test Reporting

This memo is a reminder that as part of a jurisdiction's per-election activities, the elections official shall provide notice to the public and shall conduct a test or series of tests to ensure that every device used to tabulate ballots accurately records each vote, no later than seven days prior to any election. The exact methods employed in this test shall conform to the voting procedures for the specific voting systems, as adopted by the Secretary of State, pursuant to Elections Code section 15000.

Additionally, under the California Code of Regulations, Title 2, Division 7, Chapter 4, Section 20279, during the testing of the ballot tabulating devices pursuant to Elections Code 15000, the jurisdictions approved to use a ballot on demand system shall produce the test ballots printed from its ballot on demand system to establish that the ballot on demand system is configured, calibrated, and performing as intended. Those test ballots printed from the ballot on demand system shall be scanned, tabulated, and the accuracy verified on each type of voting system component to be used in the specific election.

The Secretary of State's office is asking jurisdictions to participate in providing confirmation that a logic and accuracy test was conducted in accordance with state law. Our office has provided the attached template below for purposes of reporting the results of the jurisdictions logic and accuracy test.
