RE: General Election: Proposition Numbering

The following proposition numbers have been assigned to the ballot measures qualified for the November 5, 2024, General Election.

- Proposition 2 Education finance: school facilities: Kindergarten Through Grade 12 Schools and Local Community College Public Education Facilities Modernization, Repair, and Safety Bond Act of 2024.
(AB 247, Chapter 81, Statutes of 2024)
- Proposition 3 Marriage equality.
(ACA 5, Resolution Chapter 125, Statutes of 2023)
- Proposition 4 Safe Drinking Water, Wildfire Prevention, Drought Preparedness, and Clean Air Bond Act of 2024.
(SB 867, Chapter 83, Statutes of 2024)
- Proposition 5 Local government financing: affordable housing and public infrastructure: voter approval.*
(ACA 1, Resolution Chapter 173, Statutes of 2023)
- Local government financing: affordable housing and public infrastructure: voter approval.*
(ACA 10, Resolution Chapter 134, Statutes of 2024)
- Proposition 6 Slavery.

- Proposition 32 Raises Minimum Wage. Initiative Statute.
