Ann-Louise Kuhns, the proponent of EXPANDS STATE HEALTH CARE PROGRAM FOR CHILDREN WITH CERTAIN MEDICAL CONDITIONS. INITIATIVE STATUTE., has filed more than 546,651 signatures with the counties.

Therefore, pursuant to Elections Code section 9030(d), you are required to verify 500 signatures or three percent of the number of signatures filed, whichever is greater.
