Recommendations to SOS from State VAAC working group: Outreach to voters who do not identify as persons with a disability

April 16, 2025

1. Description of the recommendation:

The working group is offering simple suggested language which counties can use in their general voter outreach campaigns in order to reach voters who do not use standard disability-related terminology or do not realize that they are eligible for extra assistance. It is hoped that these proposed phrases appear in outreach that reaches all voters, not just in materials designed for those with identified disabilities or agencies who work with persons with disabilities.

The committee recommends that the SOS assist the working group with packaging this messaging to the counties and bringing a recommendation back to the VAAC at its meeting on June 18, 2025.

Suggested language could include the following:

- Want to vote by mail but can't fill out the ballot? Contact your elections department to learn how to do this independently.
- Want to vote in person but have trouble seeing or hearing? Contact your elections department to learn how to vote independently or to get help.
- Can't get to the vote center or precinct? Contact your elections department for help finding options.
- Want someone to help you mark your ballot? Poll workers can do this. Two workers will be present to ensure accurate marking.
- Having trouble reading your sample ballot? Call your elections department for assistance.
- Do you need help getting inside the vote center or polling place? Contact your elections department and they'll help you get in, or meet you at your vehicle.
- Start planning your voting early in case you need more time to access voter materials.
- Your elections department is here for you. Contact us and we'll show you the ways to vote your way!

2. Reason for this recommendation

It has come to the committee's attention that an increasing number of voters may be facing difficulties participating in the voting process because they do not identify as persons with a disability and do not realize what services are available to assist them. If small mentions

of services are included in general public service announcements, these voters may be directed to available help, or family members can help inform voters and encourage them to fully participate in the voting process.

3. Where this recommendation should be sent to or updated at (i.e., SOS webpage or sent to counties as a voluntary survey)

Recommendation should be sent to counties as suggested good practices and cost effective outreach.

4. Proposed timeline for this recommendation to be implemented (i.e., before the November 2024 General Election)

This recommendation could be implemented by June, 2025 to allow counties time to plan future materials.
