RE: Statewide Special Election: State Voter Information Guide Order Form

Please provide on the attached state Voter Information Guide Order Form the number of state Voter Information Guides (VIGs) your county will need for the upcoming November 4, 2025, Statewide Special Election. Please include any special shipping instructions you may have and return the completed order form to me by August 27, 2025.

If your county will need state VIGs delivered to multiple locations, please specify the special shipping instructions pertinent to each location. Please be sure to indicate whether you would like the guides shipped in cartons, on pallets, in cartons on pallets, or any combination of the three.

The Secretary of State (SOS) will mail state VIGs directly to all non-military voters with domestic mailing addresses (including U.S. territories) who are registered by September 5, 2025 (E-60) (first mailing), as well as to those registered between September 6, 2025 (E-59) and October 6, 2025 (E-29) (second mailing).

PLEASE NOTE: Counties will be responsible for mailing state VIGs to (1) military and overseas voters with addresses in the foreign files provided by the VoteCal team, (2) voters with addresses in the error files provided by the VoteCal team, (3) confidential voters, and (4) voters registered after E-29 upon voter request only.

The SOS will mail state VIGs to non-military voters with domestic mailing addresses (including U.S. territories) registered at E-60 and E-29.

Pursuant to Elections Code section 9094(b), three copies of the state VIG must be kept at every polling place while an election is in progress so that they may be freely consulted by the voters. We also recommend providing polling places with state VIGs in the languages required in your county pursuant to Section 203 of the Voting Rights Act.

Please make sure you order plenty of state VIGs to supply all polling places and vote centers and to mail to voters who request a copy. Please note that we cannot reimburse for any automatic mailings to voters registered after E-29, only those where you received a specific request from a voter.

Once the county order information has been compiled, we will send you a copy of your completed order and shipping instructions, which will require your confirmation. You will have an opportunity to make any changes at that time.
