RE: Statewide Special Election: Election Certification; Ballot Identification

Envelopes: Noncomparable Signatures and Unsigned Envelopes

<u>Senate Bill (SB) 280</u> (Chapter 97, Statutes of 2025) addresses the election certification and signature cure deadlines in place for the November 4, 2025, Statewide Special Election. This memorandum will cover that, as well as serve as a reminder regarding the following:

- noncomparable signatures and unsigned ballot identification envelopes,
- that the procedures that apply to the comparison of signatures on vote-by-mail ballot identification envelopes, also apply to provisional ballot identification envelopes; and
- the signature comparison process set forth in subdivision (a) of Section 3019.

Courtesy samples of a Signature Verification Statement, an Unsigned Identification Envelope Statement, and a combined statement are attached to this CCROV.

Election Certification and Signature Cure Deadlines

Pursuant to SB 280, "the elections official shall not certify the results of the November 4, 2025, statewide special election prior to the 28th calendar day following the election." (SEC. 3, subd. (f)(1).) For the November 4 election, <u>E+28 is Tuesday, December 2, 2025.</u>

However, SB 280 also states that if there are no vote-by-mail ballots remaining for which a voter has the opportunity either to verify their signature or to provide their signature and they have not already done so, "the elections official may certify the results of the November 4, 2025, statewide special election prior to the 28th calendar day following the election." (SEC. 3, subd. (f)(2); Elec. Code, § 3019, subds. (d), (e).)

With respect to the "signature cure" deadline, SB 280 provides that "the elections official shall accept a completed signature verification statement, unsigned identification envelope statement, or a combined vote by mail ballot signature verification statement and unsigned identification envelope statement until 5 p.m. on the 26th calendar day following the November 4, 2025, statewide special election." (SEC. 3, subd. (g).) For the November 4 election, E+26 is Sunday, November 30, 2025.

Courtesy samples of a Signature Verification Statement, an Unsigned Identification Envelope Statement, and a combined statement have been updated with the November 30 date and are attached to this CCROV.

Noncomparable Signatures

A minimum of eight days prior to certification of the election, the elections official shall provide notice and instructions to all voters identified as having noncomparable signatures on their vote-by-mail ballot identification envelopes or their provisional ballot identification envelopes. (Elec. Code, § 3019, subds. (d)(1), (f).)

The notice must be sent with a postage-paid return envelope, and it must be sent to a voter on or before the next business day after the determination of the noncomparable signatures. The notice must indicate they have the opportunity to verify their signatures until no later than 5 p.m. two days prior to the certification of the election*. The notice must also include a statement that the signature provided by the voter may be added to the voter's registration record to be used for signature comparison purposes in future elections. (Elec. Code, § 3019, subds. (d)(1), (f); Cal. Code Regs. tit. 2, §§ 20990(d), (e), 20992(d), (e).)

If an elections official has a telephone number or email address on file for a voter whose signature does not compare, the elections official shall notify the voter by telephone, a text message, or email of the opportunity to verify their signature. If an elections official calls the voter and the voter does not answer, the elections official shall attempt to leave a voicemail message. (Elec. Code, § 3019, subd. (d)(1)(B).)

County elections officials shall not reject a vote-by-mail ballot or a provisional ballot for the reason of noncomparable signatures if one of the following occurs:

- The voter completes and submits a Signature Verification Statement (or the combined statement) to a polling location within the county or a ballot drop-off box, before the close of the polls on Election Day, or
- 2) The voter delivers, in person or by mail, fax, email, or other means, a Signature Verification Statement (or the combined statement) signed by the voter and the county elections official receives it no later than 5 p.m. two days prior to the certification of the election*,

and

the voter's signature on the Signature Verification Statement (or the combined statement) compares with the signature(s) in the voter's registration record.

(Elec. Code, § 3019, subds. (d)(4)(A), (B)(i), (f).)

If the signature on the Signature Verification Statement (or the combined statement) does not compare, the ballot identification envelope shall not be opened, the ballot shall not be counted, and the elections official shall write the cause of the rejection on the face of the identification envelope. (Elec. Code, § 3019, subds. (d)(4)(B)(ii), (f).)

*Pursuant to SB 280, for the November 4, 2025, Statewide Special Election, county elections officials shall accept cures until 5 p.m. on November 30, 2025 (E+26), and, in most circumstances, shall not certify the results of the election prior to December 2, 2025 (E+28).

Unsigned Ballot Identification Envelopes

A minimum of eight days prior to certification of the election, the elections official shall provide notice and instructions to all voters identified as having failed to sign their vote-by-mail ballot identification envelopes or their provisional ballot identification envelopes. (Elec. Code, § 3019, subd. (e)(1)(B).)

The notice must be sent with a postage-paid return envelope, and it must be sent to a voter on or before the next business day after the determination of the missing signature. The notice to the voters must indicate that they have the opportunity to provide a signature until no later than 5 p.m. two days prior to the certification of the election*. The notice must also include a statement that the signature provided by the voter may be added to the voter's registration record to be used for signature comparison purposes in future elections. (Elec. Code, § 3019, subds. (e)(1)(B), (f); Cal. Code Regs. tit. 2, §§ 20990(d), (e), 20992(d), (e).)

If an elections official has a telephone number or email address on file for a voter who has failed to sign the identification envelope, the elections official shall notify the voter by telephone, a text message, or email of the opportunity to provide a signature. If an elections official calls the voter and the voter does not answer, the elections official shall attempt to leave a voicemail message. (Elec. Code, § 3019, subd. (e)(1)(B)(ii).)

County elections officials shall not reject a vote-by-mail ballot or a provisional ballot for the reason of an unsigned ballot identification envelope if one of the following occurs:

1) The voter signs the ballot identification envelope at the office of the county elections official during regular business hours, no later than 5 p.m. two days prior to the certification of the election*,

- 2) The voter completes and submits an Unsigned Identification Envelope Statement (or the combined statement) to a polling location within the county or a ballot drop-off box, before the close of the polls on Election Day, or
- 3) The voter completes and submits an Unsigned Identification Envelope Statement (or the combined statement) to the county elections official in person or by mail, fax, email, or other means made available by the elections official, no later than 5 p.m. two days prior to the certification of the election*,

and

the voter's signature on the Unsigned Identification Envelope Statement (or the combined statement) compares with the signature(s) in the voter's registration record.

(Elec. Code, § 3019, subds. (e)(1)(A)(i), (ii), (iii), (C)(i), (f).)

If a determination is made that the signature on the Unsigned Identification Envelope Statement (or the combined statement) does not compare to the signature(s) in the voter's registration record, the ballot identification envelope shall not be opened, and the elections official shall provide notice to the voter pursuant to subdivisions (c) and (d) of Section 3019. (Elec. Code, § 3019, subds. (e)(1)(C)(ii), (f).)

*Pursuant to SB 280, for the November 4, 2025, Statewide Special Election, county elections officials shall accept cures until 5 p.m. on November 30, 2025 (E+26), and, in most circumstances, shall not certify the results of the election prior to December 2, 2025 (E+28).

Signature Comparison - Statutory and Regulatory Information

Subdivision (a) of Elections Code section 3019 provides the following with respect to signature comparison, including, the comparison of a voter's signature on a Signature Verification Statement, an Unsigned Identification Envelope Statement, or a combined statement, with the signature that is part of the voter's registration record:

- A presumption exists that the signature on the identification envelope, signature verification statement, unsigned identification envelope statement, or provisional ballot envelope is the voter's signature.
- An exact match is not required for an elections official to determine that a voter's signature is valid. The fact that signatures share similar characteristics is sufficient to determine that a signature is valid.
- The elections official shall consider explanations for discrepancies between signatures that are specified in regulations promulgated by the Secretary of State. Explanations include a variation in signature style over time and the haste with which a signature is written.

- When comparing signatures, an elections official shall not review or consider a voter's party preference, race, or ethnicity.
- The elections official may consider characteristics of the written signature that are specified in regulations promulgated by the Secretary of State.
 - Characteristics include the slant of the signature, letter formation, and whether the signature is printed or written in cursive.
- The elections official may use facsimiles of voters' signatures, provided that the method of preparing and displaying the facsimiles complies with the law.
- In comparing signatures, an elections official may use signature verification technology. If signature verification technology determines that the signatures do not compare, the signature is subject to these additional procedures.
 - The signature shall be rejected only if two additional elections officials each find beyond a reasonable doubt that the signature differs in multiple, significant, and obvious respects from all signatures in the voter's registration record.
- The variation of a signature caused by the substitution of initials for the first or middle name, or both, is not grounds for the elections official to determine that the signatures do not compare.
- A signature made using a mark such as an "X", or made by a signature stamp, shall be presumed valid and shall be accepted if the signature meets the requirements of Section 354.5.

Elections Code section 3019 also provides for the following:

- County elections officials shall include a single, combined signature verification statement and unsigned identification envelope statement, along with the instructions, on their internet websites.
 - They shall also provide their mailing address, email address, and facsimile transmission number on the internet web page containing the statement and instructions. (Elec. Code, § 3019, subd. (f).)
- County elections officials may mail the combined statement to a voter in lieu of the Signature Verification Statement or Unsigned Identification Envelope Statement. (Elec. Code, § 3019, subd. (f).)
- The notices and the instructions to voters related to noncomparable signatures and unsigned ballot identification envelopes must be translated in all languages required in the county by Section 203 of the federal Voting Rights Act of 1965 (52 U.S.C. § 10503). (Elec. Code, § 3019, subds. (d)(3), (e)(3).)
- Information related to voters who did not sign their ballot identification envelope
 or whose signature on their ballot identification envelope did not compare to the
 voter's signature(s) in the voter's registration record shall be treated as
 confidential voter registration information. This information shall be provided with
 respect to any voter, subject to the provisions of Sections 2166, 2166.5, 2166.7,
 2166.8, and 2188, to any candidate for federal, state, or local office, to any
 committee for or against any initiative or referendum measure for which legal
 publication is made, and to any person for election, scholarly, journalistic, or

political purposes, or for governmental purposes, as determined by the Secretary of State, but otherwise shall not be disclosed to any person. Any disclosure of this information shall be accompanied by a notice to the recipient regarding Sections 18109 and 18540. Voter information provided pursuant to this subdivision shall be updated daily, include the name of the voter, and be provided in a searchable electronic format. (Elec. Code, § 2194, subd. (f); Gov. Code, § 7924.000.)

 A local elections official offering other electronic means for submission of a statement described in this CCROV shall establish appropriate privacy and security protocols that ensure that the information transmitted is received directly and securely by the elections official and is only used for the stated purposes of verifying the signature on the voter's ballot. (Elec. Code, § 3019, subd. (g).)

Additionally, the procedures that apply to the comparison of signatures on vote-by-mail ballot identification envelopes apply to provisional ballot identification envelopes. (See, Elec. Code, § 14310, subd. (c)(1); Cal. Code Regs. tit. 2, § 20992; discussion in Chapter 5 of the California NVRA Manual.) Accordingly, the notices and cure periods related to noncomparable signatures on vote-by-mail ballot identification envelopes and unsigned vote-by-mail ballot identification envelopes also apply to noncomparable signatures on provisional ballot identification envelopes and unsigned provisional ballot identification envelopes.

The updated courtesy samples of a Signature Verification Statement, an Unsigned Identification Envelope Statement, and a combined statement are attached to this CCROV. Once translations of these statements are available, they will be sent out by Victoria Estrada in a separate communication.
