RE: General Election: Required Public Notices and Voter Education and Outreach Materials

The California Secretary of State (SOS) is now taking orders for required public notices and a variety of outreach and educational materials for the November 3, 2026, General Election. Many of these are available in print and are available for download on our website.

County elections officials are required to post notices regarding the prohibition of electioneering and corruption of the voting process. (Elec. Code, §§ 18372, 18504.) These notices **shall** be posted on county elections officials' websites, and conspicuously at all buildings that contain a polling place (including an election official's office or a satellite location) and any outdoor site (including a curbside voting area and a vote-by-mail ballot drop box) at which a voter may cast or drop off a ballot. (Cal. Code Reg., tit. 2, §§ 20180, 20181.) To assist counties with these posting requirements, the Secretary of State has created combined notices that are available for counties to order or download.

Pursuant to Elections Code section 14105(m), Voter Bill of Rights posters **shall** be posted inside and outside each polling place or vote center in every language required in your county. These posters are available in print and electronic formats.

As you prepare for voter education and outreach activities, the SOS would like to also provide counties with the opportunity to order additional supplies the Secretary of State offers that are not required by law. All the educational materials we offer are provided at no cost. Supplies are limited and will be shipped as they become available.

**Print materials available for order and download include the following:**

**1. Required Public Notices:**

**Prohibition of Electioneering and Corruption:** The 11" x 17" poster contains both notices and is available in English, Spanish, Chinese, Hindi, Japanese, Khmer, Korean, Tagalog, Thai, and Vietnamese. These publications can also be found online at [sos.ca.gov/elections/publications-and-resources](https://sos.ca.gov/elections/publications-and-resources).

**Voter Bill of Rights:** This publication is available in an 8 1/2" x 11" format in the following languages: English, Spanish, Chinese, Hindi, Japanese, Khmer, Korean, Tagalog, Thai, and Vietnamese.

The 8 1/2" x 11" version is also available in Arabic, Armenian, Bengali, Burmese, Chinese (Traditional), Farsi (Persian), Filipino, Gujarati, Hmong, Ilocano, Indonesian, Lao (Laotian), Lu Mien (Mien), Malay, Mongolian, Nepali, Pashto, Punjabi, Russian, Syriac, Tamil, Telugu, Ukrainian, and Urdu.

**Note:** Ilocano, Syriac, and Tamil versions are available while supplies last.

**2. Voter Education and Outreach Materials:**

**Pre-registration Flyer:** This two-sided flyer provides information about pre-registration for 16- and 17-year-olds. It includes details about how to pre-register to vote online, when to pre-register to vote, and the requirements to pre-register to vote. **Time Off to Vote:** This notice reflects California Elections Code section 14001, which requires employers to post a notice to employees advising them of provisions for taking paid leave for the purpose of voting in statewide elections. **Quick Facts 2026 - General Election Flyer:** This flyer is a comprehensive document that addresses frequently asked questions. **California Online Voter Registration Application Quick Response (QR)**

**Code:** QR codes are a great resource for voters “on the go.” These images can be scanned with smart phones and will automatically direct the user to the online voter registration application. The online voter registration application QR code can be printed on stickers or used in outreach pamphlets. Once the user scans the code, they are given the option to fill out a voter registration application online. **Register To Vote Buttons:** These buttons can be placed on any website to promote online voter registration. Available in ten languages, these buttons are an outreach tool that state and local governments, organizations, businesses, schools, etc., can use to promote voter registration. When people click on the register to vote button, they are directed to the online voter registration application.
