- RE: VoteCal: CDPH Death Records

The California Department of Public Health (CDPH) has changed their deceased records management system. The Secretary of State (SOS) has been working with the VoteCal project team and the Election Management System (EMS) vendors to modify the VoteCal Deceased Match messages in order to provide counties with the new set of information. The Potential Deceased Match to Voter and Potential Deceased Match messages, from VoteCal to the county EMS, will now contain data from the new CDPH files received by the SOS.

For the two Deceased Match messages above, the attached document, VoteCal Deceased Match Changes, shows the differences in the raw data set contained in the messages from VoteCal to the county EMS. While some previous fields will no longer be provided, these fields will be maintained for backward compatibility. All those fields marked as "BLANK" on the attachment will show as an empty field in the raw data.
