DEFINES LEGAL STANDARD FOR CLAIM OF SELF-DEFENSE IN CERTAIN CRIMINAL PROSECUTIONS OF LAW-ENFORCEMENT OFFICERS. REQUIRES JURY TRIAL FOR SPECIFIED CRIMINAL PROSECUTIONS OF LAW-ENFORCEMENT OFFICERS. INITIATIVE CONSTITUTIONAL AMENDMENT.

CIRCULATING AND FILING SCHEDULE

1. Minimum number of signatures required: 585,407
California Constitution, Article II, Section 8(b), Elections Code § 9035
2. Official Summary Date: Friday, 10/27/17
3. Petitions Sections:
 - a. First day Proponent can circulate Sections for signatures (Elections Code §§ 336, 9014(a)) Friday, 10/27/17
 - b. Last day Proponent can circulate and file with the county. All sections are to be filed at the same time within each county. (Elections Code §§ 9014, 9030(a))..... Wednesday, 04/25/18
 - c. Last day for county to determine total number of signatures affixed to petitions and to transmit total to the Secretary of State (Elections Code § 9030(b))..... Monday, 05/07/18

(If the Proponent files the petition with the county on a date prior to 04/25/18, the county has eight working days from the filing of the petition to determine the total number of signatures affixed to the petition and to transmit the total to the Secretary of State) (Elections Code § 9030(b).)
 - d. Secretary of State determines whether the total number of signatures filed with all county clerks/registrars of voters meets the minimum number of required signatures and notifies the counties (Elections Code § 9030(c))..... Wednesday, 05/16/18*
 - e. Last day for county to determine total number of qualified voters who signed the petition, and to transmit certificate with a blank copy of the petition to the Secretary of State (Elections Code §§ 9030(d) and (e))..... Thursday, 06/28/18

* Date varies based on the date of county receipt.

Circulating and Filing Schedule continued:

(If the Secretary of State notifies the county to determine the number of qualified voters who signed the petition on a date other than 05/16/18, the last day is no later than the thirtieth working day after the county's receipt of notification). (Elections Code §§ 9030(d) and (e).)

- f. If the signature count is more than 643,948 or less than 556,137 then the Secretary of State certifies the petition as qualified or failed, and notifies the counties. If the signature count is between 556,137 and 643,948 inclusive, then the Secretary of State notifies the counties using the random sampling technique to determine the validity of **all** signatures (Elections Code §§ 9030(f) and (g); 9031(a)).....Sunday, 07/08/18*

- g. Last day for county to determine actual number of all qualified voters who signed the petition, and to transmit certificate with a blank copy of the petition to the Secretary of State. (Elections Code §§ 9031(b) and (d)).....Friday, 08/17/18

(If the Secretary of State notifies the county to determine the number of qualified voters who have signed the petition on a date other than 07/08/18, the last day is no later than the thirtieth working day after the county's receipt of notification.) (Elections Code §§ 9031(b) and (d).)

- h. Secretary of State certifies whether the petition has been signed by the number of qualified voters required to declare the petition sufficient (Elections Code §§ 9031(e), 9033(a)).....Tuesday, 08/21/18*

*Date varies based on the date of county receipt.

IMPORTANT POINTS

- California law prohibits the use of signatures, names, and addresses gathered on initiative petitions for any purpose other than to qualify the initiative measure for the ballot. This means that the petitions cannot be used to create or add to mailing lists or similar lists for any purpose, including fundraising or requests for support. Any such misuses constitutes a crime under California law. Elections Code § 18650; *Bilofsky v. Deukmejian* (1981) 124 Cal.App.3d 825, 177 Cal.Rptr. 621; 63 Ops.Cal.Atty.Gen. 37 (1980).
- Please refer to Elections Code §§ 100, 101, 104, 9008, 9009, 9012, 9013, 9020, 9021, and 9022 for appropriate format and type consideration in printing, typing, and otherwise preparing your initiative or referendum petition for circulation and signatures. Please send a copy of the petition after you have it printed. This copy is not for our review or approval, but to supplement our file.
- Your attention is directed to the campaign disclosure requirements of the **Political Reform Act of 1974**, Government Code § 81000 et seq.
- When writing or calling state or county elections officials, provide the official title of the initiative or referendum which was prepared by the Attorney General. Use of this title will assist elections officials in referencing the proper file.
- When a petition is presented to the county elections official for filing by someone other than the proponent(s), the required authorization shall include the name or names of the persons filing the petition. Elections Code § 9032.
- When filing the petition with the county elections official, please provide a blank petition for elections official use.
