Each month, the Office of Voting Systems Technology Assessment (OVSTA) provides an update on Election Assistance Commission (EAC) and Secretary of State (SOS) activities related to voting technology.

# **Recent and Upcoming Events**

The proposed Electronic Poll Book regulations were approved by the Office of Administrative Law, the state agency responsible for reviewing and approving state regulations, and became effective on May 16, 2018. Governor Brown has proposed a one-time expenditure of \$134 million in California's 2018-2019 budget to replace voting systems for all of the state's 58 counties. The funding is to be provided as a one-time General Fund spending to purchase new hardware, software, and initial licensing to replace existing systems and technology. However, counties will be required to provide a dollar-for-dollar match to receive the state funding. The proposal has been heard by both the Senate and the Assembly and the final details are being conferred.

#### **Testing and Certification at the EAC**

The EAC provides <u>updates</u> on voting system testing. As of the last update on May 23, 2018, the current testing and certification status for systems relevant to California is:

**Dominion Democracy Suite DVS 5.5.** Currently in the Testing Phase, but is on hold while Dominion Voting Systems works on a root cause analysis and internal testing for a deficiency that occurred during testing.

**ES&S EVS 6.0.0.0.** The EAC is currently reviewing version 2.0 of the Test Report for this system.

**ES&S EVS 5.4.1.0.** The EAC certified this system on May 23, 2018.

**ES&S EVS 5.2.4.0.** The EAC is reviewing and providing comments to the VSTL on the initial version of the Test report for this system.

The EAC's "Voting Systems Under Test" and "Certified Voting Systems" pages provide more specifics on each voting system.

#### **Defects, Failures, and Faults**

There were no defects, failures or faults of a voting system or ballot printer reported to OVSTA in May.

## <u>Disposal or Sale of Equipment Purchased with Help America Vote Act (HAVA)</u> <u>and/or Voting Modernization Bond (VMB) Funding</u>

In 2012, the California Secretary of State issued guidance regarding the disposition or sale of equipment purchased with HAVA and/or VMB funding. See Secretary of State (SOS) County Clerk/Registrar of Voters (CC/ROV) Memorandum #12219 - Handling the Sale and Funds from the Sale of Voting Systems or Voting Equipment. The document outlines proper disposal or sale procedures of voting systems or voting equipment purchased with HAVA and/or VMB funding. The document also highlights that all equipment must be void of any software or firmware and returned to a condition of a non-functioning piece of hardware prior to its disposal or sale.

Also, the EAC issued <u>Election Assistance Commission (EAC) Funding Advisory Opinion FAO-08-007</u>. The document outlines proper disposal or sale account procedures for original or replacement equipment acquired with HAVA funding.
