RE: Initiative: Random Sample of #1830, Related to Taxes

Thomas W. Hiltachk, the proponent of ELIMINATES RECENTLY ENACTED ROAD REPAIR AND TRANSPORTATION FUNDING BY REPEALING REVENUES DEDICATED FOR THOSE PURPOSES. REQUIRES ANY MEASURE TO ENACT CERTAIN VEHICLE FUEL TAXES AND VEHICLE FEES BE SUBMITTED TO AND APPROVED BY THE ELECTORATE. INITIATIVE CONSTITUTIONAL AMENDMENT. has filed more than 585,407 signatures with the counties.

Therefore, pursuant to Elections Code section 9030(d), you are required to verify 500 signatures or three percent of the number of signatures filed, whichever is greater. If you received less than 500 signatures, you are required to verify all the signatures filed with your office and certify the number of valid signatures.

Please note: Pursuant to Elections Code section 9030(e), you must attach an original blank petition (not a faxed copy) to your random sample certification.

You have until June 25, 2018, (30 working days from the date of this notice) to finish your verification. If we produce the random for you, you have 30 working days from the date you receive the set of numbers. If you need a set of random numbers produced for you, please contact me at the number below or at rbradshaw@sos.ca.gov.
