- RE: Notice to Verify all Signatures Received as of the Third Reporting Date for the Recall of Governor Gavin Newsom, Filed by Erin Cruz

Pursuant to Elections Code section 11104(d), counties shall not begin the signature verification process until the number of received signatures in a recall attempt reaches 10% of the total required signatures needed to qualify the recall for the ballot.

As of December 6, 2019, the Recall of Governor Gavin Newsom (filed by Erin Cruz) effort reached the required number of signatures needed in order to initiate the signature verification process.

Pursuant to Elections Code section 9031(b), counties must verify all signatures received as of November 27, 2019, and shall report to the Secretary of State the number of verified signatures within 30 days, excluding Saturdays, Sundays, and holidays.
