RE: Notice to Verify all Signatures Received as of the Sixth Reporting Date
for the Recall of Governor Gavin Newsom, Filed by Mr. Orrin E. Heatlie

Pursuant to Elections Code section 11104(d), counties shall not begin the signature verification process until the number of received signatures in a recall attempt reaches 10% of the total required signatures needed to qualify the recall for the ballot.

The Recall of Governor Gavin Newsom effort (filed by Orrin E. Heatlie) has reached the required number of signatures needed in order to initiate the signature verification process.

Pursuant to Elections Code section 11104 and 9031(b), counties must verify all signatures received as of December 7, 2020, and shall report to the Secretary of State the number of verified signatures by January 13, 2021, the deadline for the seventh report.
