As of September 6, 2019, the Secretary of State's office approved petitions for circulation for the Recall of Governor Gavin Newsom by Erin Cruz. Also, as of December 6, 2019, the Recall of Governor Gavin Newsom (filed by Erin Cruz) effort reached the required number of signatures needed in order to initiate the signature verification process.
