RE: March 3, 2020, Presidential Primary Election Canvass Extension

March 20, 2020, Governor Newsom issued <u>Executive Order N-34-20</u>, which, among other things, extends all deadlines associated with the official canvass of the March 3, 2020, Presidential Primary Election by 21 days.

Based upon this Executive Order, the following canvass-related deadlines for county elections officials and the Secretary of State have been extended as follows (the number preceding the entry is the number of the entry in the March 3, 2020, Primary Election Calendar found at <u>https://elections.cdn.sos.ca.gov//statewide-elections/2020-primary/section-5-primary-calendar.pdf</u>):

151. Vote-By-Mail Ballots – Notice to Cure Mismatched Signature on Identification Envelope or Unsigned Identification Envelope – The deadline moves from to March 25, 2020, to April 15, 2020.

153. Statement of Results to Secretary of State – Presidential Delegates – The deadline moves from March 31, 2020, to April 21, 2020.

155. Vote-By-Mail Ballots – Deadline to Cure Mismatched Signature on Identification Envelope or Unsigned Identification Envelope – The deadline moves from March 31, 2020, to April 21, 2020.

156. Estimated Number of Unprocessed Ballots – Final Report – The deadline moves from April 2, 2020, to April 23, 2020.

157. Official Canvass Deadline – The deadline moves from April 2, 2020, to April 23, 2020.

159. Statement of Results to Secretary of State – The deadline moves from April 3, 2020, to April 24, 2020.

160. Presidential Primary Results Compiled by the Secretary of State – The deadline moves from April 4, 2020, to April 25, 2020 (Saturday).

162. Statement of Vote – The deadline moves from April 10, 2020, to May 1, 2020.

164. Certificates of Nomination – All Voter-Nominated, Non-Presidential Candidates – The deadline moves from April 13, 2020, to May 4, 2020.

165. Green Party County Council Certification – The deadline moves from April 17, 2020, to May 8, 2020.

169. Supplement to the Statement of the Vote – The deadline moves from August 8, 2020, to August 29, 2020.

Our office will separately contact the county elections officials impacted by the Executive Order as it relates to the May 12, 2020, Special General Elections to be held in Senate District 28 and Congressional District 25.
