1% POST ELECTION MANUAL TALLY

In accordance with California Elections Code §15360, the County of Santa Clara Registrar of Voters conducted a manually tally of precincts for the November 3rd, 2020 Presidential General Election.

- The 1% Precincts were randomly selected using DFM EIMS software computerized random number generator job # EWMR082 on November 18th, 2020 at 1:06:39 p.m.
- The 1% Post Election Manual Tally was conducted from November 23, 2020 – December 2, 2020.
- The Manual Tally was performed on 41 precincts out of a total of 596 precincts in the election. All contests were tallied in 7 precincts (one of the precincts has no registered voter), and select contests were tallied in the remaining 34 precincts to ensure that all contests were included. The canvass teams counted one contest at a time and added the votes received and compared the totals with the reports from the ImageCast Central Tabulating Machine Report.
- Any discrepancy that was found was resolved in the 1% Post Election Manual Tally.
- A summary of the precincts tallied is attached.
