The Solano County Registrar of Voters issued public notice for random draw of the 1 Percent Manual Tally per EC 15360 with the random selection to commence Friday, November 13th at 10:00 a.m. Two observers from the public attended. The audit was conducted continuously from Friday morning until the following Friday, November 20th until all precincts and batches were completed.

Five polling places were randomly drawn for complete manual tally. A total of 10 Precincts out of 348 (2.8%), comprised within the 5 poll places out of 100 were selected (5%). The manual tally confirmed the machine counts for both precinct ballots as follows:

For ballots cast by mail, Solano county utilized batches of up to 200 ballots to count vote by mail ballots. Twenty batches were initially randomly drawn, and twenty additional batches were added to ensure all races were audited. For each batch, all races on the ballots were audited. Batches of ballots are roughly sorted into supervisorial district throughout the county. The chart below shows the major area of the county that are included in the

matches shown below. The manual tally confirmed the machine counts for vote by mail ballots as follows:

Overall, 348 of 348 precincts (100%), 40 of 972 vote by mail batches (4.1%), representing 7,136 of 178,511 vote by mail ballots cast (3.99%) were manually audited. In each case, the hand count of ballots matched the machine count produced on election night.
