*Initial Random Selection:* Batch numbered tickets 1-656 representing 656 Ballot Marking Device (BDM) ballots and batch numbered tickets 1-1,332 representing 1,332 Declared Vote By Mail (VBM) batches for the **March 3, 2020 Presidential Primary Election** were placed inside a rotating drum, and batches were randomly drawn by Elections Official representatives and three (3) public observers. The initial random selection consisted of seven (7) BMD and fourteen (14) VBM batch numbers.


