Because we are a small county, we always canvass one batch from each of the ICE machines that are at our two separate polling locations. Then, two batches which have gone through the ICC scanner are chosen at random.

Four batches were canvassed. We had one batch from each of our poll place ICE machines, and two batches chosen at random that were run through our ICC machine in our main tally location. All four batches matched 100% to what was printed out of the Democracy Suite tally system.
