**NOTICE IS HEREBY GIVEN** that the Elections Division of the Madera County Clerk-Recorder's office will randomly draw the precincts to be hand-tallied as a check of the ballot counting equipment on Wednesday, September 15, 2021, at 8:00 a.m. in the office of the County Clerk, 200 West 4<sup>th</sup> Street, Madera.

One precinct, which includes votes from the precinct and vote by mail ballots, will be selected at random. After the drawing of the random precinct number, additional random precincts will be selected, in order that one precinct is hand-tallied for each contest on the ballot.

The manual tally may commence on or about Thursday, September 16, 2021, and will continue daily, Saturdays, Sundays, and holidays excepted, at the same location, from 9 a.m. until 5:00 p.m., except for breaks and lunch hours.
