We rolled a 10-sided die to determine the number of times to generate the list and then used the final list to select precinct ballots and batches of vote-by-mail ballots. For example: If we rolled a five, we would generate five lists of numbers and use the last list to select the precincts and batches.

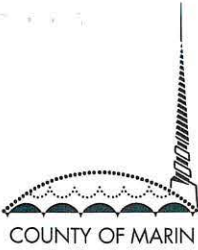
