Description of any discrepancies noted (include details about each discrepancy and how each was resolved; also include anything unusual observed during the manual tally process or anything that may improve the manual tally process):

Two discrepancies were noted during the manual tally. Both discrepancies involved voter error; that is, the voter failed to mark their choice properly in the bubble as directed in the voter instructions. Instead, one voter circled their YES choice, and the other wrote YES next to the printed word YES on the ballot. These discrepancies resulted in two additional YES votes for the recall question contest when compared to the machine tally for the selected batches.

San Luis Obispo opted for the 2-part manual tally as allowed per EC 15360.

For the first part, we have 93 precincts $\times 1\% = .93 = 1$ precinct. We used a set of three 10-sided dice to choose the 3-digit precinct to be tallied. The dice are colored red, white, and blue, and we assigned each dice in color order to relate to the same digit in the precinct number. We continued rolling until a precinct in range was rolled. This occurred when the red die rolled a 1, the white die a 1, and the blue die a 3 = precinct 113. List attached (attachment #3) describes all precincts with the number of ballots in each as of the semifinal official canvass at the end of the night on September 14, 2021.

For the second part, we used our semifinal official canvass, which is described in EC 15150 as "commencing immediately upon the close of the polls and continuing without adjournment until all precincts are accounted for". Our VBM number on our semifinal official canvass was 52,800 VBM ballots. 1% of 52,800 = 528 ballots. We batch our counted ballots in batches of 200 count, so 3 batches were required per EC 15360(a)(2)(B)(i). Per EC 15360(a)(2)(B)(II), we chose to add an additional 2 batches of VBM ballots (400 additional ballots) to the manual tally. Per our semifinal official canvass, we had processed 264 batches. However, on the day we rolled for our random batch numbers, we included all 521 batches processed up until September 29, 2021 in the list of available batches to allow all batches to be among the batches available to be chosen. The attached list (attachment #4) describes each batch with the number of ballots in each.

We have 6 tabulators that assign their own numbers to batches, so we organized all batches tabulated on the morning of September 29 into the order in which they were accepted into the system, and numbered them 1 through 521. We then assigned the three digits on the attached batch spreadsheet to the red, white, and blue dice as we did for the precinct selection. Our observers took turns rolling the colored dice and produced batches #41 (ICC2VBM-17), #49 (ICC4VBM-16), #175 (ICC4VBM-30), #237 (ICC5VBM-47), and #299 (ICC5VBM-59).
