No tabulation errors were identified. No adjudication errors were identified.

One extra ballot was found in voting precinct 226 during the Manual Tally. Review indicated that the vote center staff had improperly placed a unread ballot in with tabulated ballots. All ballots for the vote center were re-run, with the results changing only by the found ballot. The new precinct 226 report with the added ballot matched the manual tally results.



The Fresno County Elections office will be performing the following election activities for the November 8, 2022, Consolidated Statewide General Election:

Random Selection:

Pursuant to Elections Code Section 15360(d), the random selection of precincts for the 1% Manual Tally of votes for the **November 8, 2022, Consolidated Statewide General Election** will take place **Thursday, November 10, 2022, at 9:00a.m.** at the office of the Fresno County Clerk/Registrar of Voters, **2221 Kern Street, Fresno, California, 93721**. A public viewing of the material to be used in the random drawing will be held at **8:45 a.m.** prior to the selection process. No photography or videotaping of the selection will be permitted.

If applicable, and pursuant to the Secretary of State's voting system verification requirements, the random selection of additional precincts representing all ballot readers used for tabulation on Election Night, but not selected in the initial random drawing, will also take place on this date. A public viewing of the material to be used in the selection process will be held at 8:45 a.m. prior to the drawing.

1% Manual Tally Process:

The manual tally process for selected precincts/contest is scheduled to begin **Tuesday, November 15, 2022 at 9:00 a.m.** at the Fresno County Elections Warehouse, **4525 E. Hamilton Avenue, Fresno, California, 93702** and will continue daily, **Monday through Friday 8:00 a.m. until 5:00 p.m., Saturdays 8:00 a.m. to 3:00 p.m. (to be determined on a weekly basis), Sundays and holidays excepted**, until the process is completed. (Times of operation are subject to change).
