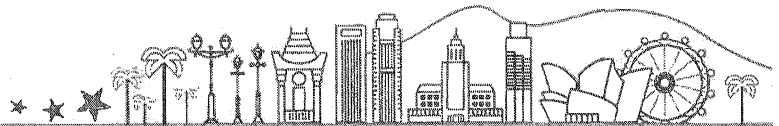

The initial random selection consisted of four (4) BMD and Twenty-eight (28) VBM batch numbers.
