The Solano County Registrar of Voters (ROV) issued public notice for random draw of the 1 Percent Manual Tally per EC 15360 with the random selection to commence Friday November 18th, at 10:00 a.m. No observers from the public attended. The audit was conducted continuously from Friday morning until November 29th when all precincts and batches were completed.

Part 1: Mandatory Audit – Minimum of 1%

During the first part of the Audit, the ROV audited enough poll place and vote by mail (VBM) ballots to meet the minimum 1% audit as follows:

Three polling places were randomly drawn for complete manual tally. A total of 7 precincts out of 215, comprised of 3 poll places out of 68 were selected. The manual tally confirmed the machine counts for all precinct ballots as follows:

For VBM Ballots Solano County utilized batches of up to 250 ballots. 17 batches of ballots were randomly drawn. An additional three batches were drawn ensure all contests were audited for a total of 20 batches. All Contests were audited on each ballot. Overall, 7 of 215 poll precincts (3.26%) and 20 of 801 VBM batches (2.49%) were completely manually audited, representing 1,210 of 18,141 poll ballots (6.67%), and 2,504 of 112,375 VBM ballots cast (2.23%). In each case, the hand count of ballots matched the machine count produced for the election.

Part 2: Supplemental Audit for Close Contests – Minimum 10%:

After processing all of the ballots for the election, the ROV identified 4 close contests that had additional audits conducted. The four contests are:

- Dixon City Council District 2 0.84% (20 vote difference)
- Fairfield City Council District 1 0.28% (12 vote difference)
- Suisun City Council District 0.62% (29 vote difference)
- Fairfield-Suisun Measure S 0.00661% (5 vote difference for 55% passage)

Seven batches plus one polling place were audited for Dixon City Council District 2, representing 189 of 1,162 ballots cast (for 16.26%).

Sixty-nine batches were manually audited for Fairfield City Council District 1, representing 736 of 5,871 VBM ballots cast (for 12.53%).

Ninety-four batches were manually audited for Fairfield-Suisun Measure S representing 4,281 of 31,954 VBM ballots cast in Solano County for Measure S (for 13.39%).

Seventy-one batches plus two polling places were audited for Suisun City Council, representing 1,499 of 11,538 ballots cast (for 12.99%).

In each case, the ROV verified that the hand count of ballots matched the machine counts.
