One Percent Post Election Manual Tall Report

November 8, 2022 Gubernatorial General Election

The Tuolumne County 1% Post Election Manual Tall identified one discrepancy between the machine count and the manual tally, Election code 15360(e). It was determined that the vote was not caught in adjudication due to the lightness of the vote. The candidate's count was increased by 1.

Ballots in the vote by mail batches A1 were counted. All federal, state, and local measures were count. This batch included 182 ballots and all races except for Lake Don Pedro Community District.

Ballots in drop off box B5 were counted. All federal, state, and local measures were count. This batch included 140 ballots and all races except for Twain Harte Community Service District.

All races were manually counted between the two batches.

the One Percent in Connection with The  
November 8, 2022, California Statewide General Election

NOTICE IS HEREBY GIVEN that, pursuant to Elections Code §15360, the elections official is required to conduct a public manual tally of the ballots tabulated by voting system devices, including vote by mail voters' ballots, in one percent of the precincts or batches chosen at random by the elections official. In addition to the one percent manual tally, the elections official shall, for each race not included in the initial group of precincts or batches selected at random, count one additional precinct or batch, and the additional precinct(s) shall apply only to the race(s) not previously counted.

NOTICE IS ALSO HEREBY GIVEN that the elections official shall provide at least a five-day public notice of the time and place of the selection of the precincts to be tallied and time and place of the manual tally prior to conducting the selection and tally. Selection of the precincts or batches to be tallied shall occur on Thursday, November 17, 2022 at 8:30 am. at the Tuolumne County Elections Office, located at 2 South Green Street, Sonora, CA 95370. The manual tally of the precincts selected shall commence no earlier than Thursday, November 17, 2022 at 10 am. at the Tuolumne County Elections Office, located at 2 South Green Street, Sonora, CA 95370.
