Description of any discrepancies noted (include details about each discrepancy and how each was resolved; also include anything unusual observed during the manual tally process or anything that may improve the manual tally process):

During the 1% Tally it was discovered that one ballot did not tabulate correctly the voter's intent. Instructions were given to voters to correct a mistaken vote by putting an "X" through the filled out voting target rectangle of the wrong choice and then filling in and circling the voting target rectangle of the correct choice. However, the voter only circled the correct choice and didn't fill in the voting target rectangle indicating their correct choice. The circle was outside of the voting target rectangle, and the ballot was not flagged for adjudication by the tabulating system. After the final votes were tallied, a manual entry, with witnesses, was performed to properly document the voter's intent. For future elections, we are adding another training element to separate out ballots with incomplete corrections in order to duplicate them and ensure the voter's intent can be captured.
