Batches were selected by a random drawing. Batch numbers were written on a piece of paper each group number was cut out and put into a container, staff randomly drew the batch number that was used during the manual hand. A full count for all contests was conducted for the San Andreas Vote Center ballots cast which included multiple precincts. The remaining vote centers manual count focused on local contests, which also included multiple precincts. Twenty-one of the vote by mail batches focused on the District 3 Supervisor race. The additional vote by mail batch was a full count of statewide offices. (see attached 1% Manual Tally)

Description of any discrepancies noted during manual tally:

- 1) San Andreas Vote Center Ballots Cast Precinct 110 – Contest: Secretary of State – Box next to contestant, Rachel Hamm was fully filled in, and the box next to contestant Matthew Cinquanta was fully filled in with the word “no” next to Matthew Cinquanta’s name. The ballot scanner read the vote as an overvote. During the manual count it was determined it should have been a vote for Rachel Hamm. This did not impact the outcome of the contest results; therefore, manual changes were not made to the results.
- 2) San Andreas Vote Center Ballots Cast Precinct 450 – Contest: Sheriff – Box next to contestant, Richard Anthony Dibasillio fully filled in, and slight mark in the write-in box. No name was written on the line. The ballot scanner read the vote as an overvote. During the manual count it was determined it should have been a vote for Richard Anthony Dibasilio. This did not impact the outcome of the contest results; therefore, manual changes were not made to the results.
- 2) Angels Camp Vote Center Ballots Cast Precinct 370 – Contest: Assessor – Box next to contestant, Larie Durham had a slight mark, however the box for write-in was completely filled in with an unofficial write-in name. The ballot scanner read the ballot as an overvote. It was determined during the manual count that the vote should have been counted as a write-in. The vote would not affected the outcome of the election, therefore no manual changes were made to the results.
- 3) Angels Camp Vote Center Ballots Cast Precinct 410 – Contest: Auditor – Box next to contestant, Kathy Gomes, had a slight black mark due to pen bleeding through from vote on contest on front side of the ballot card. The ballot scanner read it as a vote for Kathy Gomes, however it was determined during the manual count that the vote should have been counted as an undervote. The vote would not affected the outcome of the election, therefore no manual changes were made to the results.
