PUBLIC NOTICE: Schedule of Election Events – June 7, 2022 California Statewide Primary Election

The public is invited to observe as the Colusa County Registrar of Voters conducts events related to the election. With the exception of polling place observation, and poll worker training, all events will take place at the Registrar of Voters office according to the following schedule:

Vote By Mail Ballots check in. Ballots are checked in daily as they are received.

Vote By Mail Ballot Drop Box retrieval – Ballots will be retrieved from the drop box at approximately 8:45am M-F (excluding holidays) and on June 5th. Subject to change - additional dates/times may be added.

Vote By Mail Ballot Processing

June 1, 2, 3, 9:00am -12:00pm & 1:30pm-4:30pm

June 5, 8:45am – 5:00pm or until finished (closed 12-1)

June 6, 1:30pm-4:30pm

June 8 – certification or until done (vote by mail & provisional processing). Daily processing will continue during normal business hours generally from 9:00am – 4:00pm. Dates and times are subject to change based on the volume of ballots to be processed and staffing.

Election Day Observers - Polling Places

Tuesday June 7, 2022

Location: All Polling Places

Polls open at 7:00am and close at 8:00pm. Observers may arrive as early as 6:00am to watch polling place set up and stay after 8:00pm to watch closing procedures. See Observer Code of Conduct/Rules.

Election Day Observers – Elections Office

Tuesday, June 7, 2022

The office opens at 7:00am and closes when all polls have been accounted for and the Secretary of State Office verifies our unofficial reporting results. Election Night Observers are asked to arrive by 7:40P.M. to hear an overview of the election night process however observers are welcome at any time at the Election Office. Initial results will be available after 8:00pm and will include vote by mail ballots that have been received and processed in the Elections Office prior to the close of polls. Results will continue to be updated until all precincts totals are reported. Hard copies of results will be available in the office as updated results become available. Unofficial results will also be posted to the Elections Office website at the end of the night. After 8:00pm the random 1% selection of precincts will be generated using the Election Information Management System. Elections office staff are required to stay until approval is received from the Secretary of State to leave for the night.

Canvass

Thursday, June 9, 2022

The California Elections Code requires that the official canvass begin no later than the Thursday following the election, that it be open to the public, and that it continue daily (Saturdays, Sundays, and holidays excepted) for not less than six hours each day until completed. Canvass may begin prior to this date and time but must begin no later than June 9, 2022 10:00am.

One percent manual tally

Tuesday, June 14, 2022 – daily until done from 9:00am-12:00pm & 2:00pm-4:30pm. A hand count of random precincts will be conducted of those precincts selected at random on Election Night. Additional precincts may be added.
