Manual Tally Addendum - June 2022 Canvass

Precinct numbers are tumbled in jury wheel. Numbers are drawn at random.

1st number drawn is the number selected for full 100% tally.

Precincts are then pulled to cover each contest on the ballot until each contest is included in the 1%.

Outcome of 1%:

Precinct 1000:

Vote by Mail: Did not balance on first pass; upon review it was determined on 2nd pass that 1 ballot was missorted. Counts confirmed.

Vote Center: Balanced on first pass. Counts confirmed.

Precinct 2160:

Vote by Mail: Balanced on first pass. Counts confirmed.

Vote Center: Balanced on first pass. Counts confirmed.

Precinct 3000:

Vote by Mail: Balanced on first pass. Counts confirmed.

Vote Center: Balanced on first pass. Counts confirmed.

Precinct 5080 – Full Check:

Vote by Mail: Did not balance on first pass; upon review it was determined that ballots were missorted and/or voters had used wrong marking device. After 2nd pass, counts confirmed.

Vote Center: Balanced on first pass. Counts confirmed.

NOTICE IS HEREBY GIVEN that the Elections Division of the Madera County Clerk-Recorder's office will randomly draw the precincts to be hand-tallied as a check of the ballot counting equipment on Wednesday, June 8, 2022, at 8:00 a.m. in the office of the County Clerk, 200 West 4th Street, Madera.

One precinct, which includes votes from the voting precinct and vote by mail ballots from the same voting precinct, will be selected at random. After the drawing of the random precinct numbers, additional random precincts will be selected, in order that one precinct is hand-tallied for each contest on the ballot.

The manual tally may commence on or about Thursday, June 9, 2022, and will continue daily, Saturdays, Sundays, and holidays excepted, at the same location, from 9 a.m. until 4:00 p.m., except for breaks and lunch hours.
