Method used to choose precincts and batch of ballots to manually tally (include description of random selection method):

Placer County would need to randomly select 3 (three) precincts and 4 (four) batches to comply with Elections Code Section 15360. Using the EIMS One Percent Random Sample Report three precincts were selected. We ran the report six times to get six random lists of precincts and a six-sided die was used to determine which list of precincts to use. The following precinct numbers were selected on June 8, 2022: 0157127, 0356009, and 0451204. In addition, at the time of the random draw we had counted 62 batches of vote by mail ballots, mail ballots, and Uniformed and Overseas Citizens Absentee ballots. We assigned those batches numbers 1 through 62 and ran a random generator on those numbers to determine which list to use. The batches were randomly selected using a six-sided die: 27, 6, 35, 29. Further, to cover the remaining races on the ballot the following precincts were randomly selected: 0231147, 0511801, and 6131101. Furthermore, we completed a hand count of 1 additional batch before canvassing ended.
